11th Grade Testing

March 8, 2023

Dear 11th grade students and families,

The junior class of 2024, will be taking two state standardized assessments in the months of March and April that are federally mandated by the Every Students Succeeds Act to measure student achievement. We ask that all students are present and prepared for the following days:

- → March 15: Mock SAT Test Day (Practice Test)
- → March 16: Mock SAT Review (Score Practice Test)
- → March 22: SAT School Day
- → April 18-19: NM-ASR Science Assessment

SAT School Day (Paper/Pencil) - The SAT (Scholastic Assessment Test) is a national assessment used to measure knowledge and skills that can consistently predict a student's success in college and workforce training programs. The timed test will be administered on Wednesday, March 22nd in three sections: Reading, Writing & Language, and Mathematics. In order to prepare for the SAT, the 11th grade class has been receiving SAT prep in their English III class and an optional after school study group. The 11th grade class will participate in a Mock SAT Practice Test on March 15 with a session to Review on March 16.

NM-ASR Science Assessment (Computer Based Test) - The NM-ASR (New Mexico Assessment of Science Readiness) is designed to measure a student's progress towards college and career readiness, as demonstrated by making sense of phenomena and solving real-world problems when applying and connecting scientific knowledge and skills. The untimed test is administered on Tuesday, April 18 and Wednesday, April 19 in three sections.

Electronic Device Policy - Bringing an electronic device (cell phones, smart phones, smart watches, wireless earbuds, headphones, music players, iPads, tablets, laptops, etc.) into the testing area violates school and state policy, and there are grounds for confiscation, a search of the device, disciplinary action, and invalidation of the assessment. **Electronic devices may not be on a student's body. This includes in pockets or otherwise stored in clothing.** If brought to school, electronic devices must be stored in a secure location away from students. Acceptable storage includes a backpack or locker away from the testing area.

Importance of Attendance and Preparation for Test Day - It is very important that we have a 100% attendance rate for all 11th grade students on March 15, 16, 22 and April 18 and 19, 2023. Students must be present for the entire school day. Please arrange appointments and travel on non-test days. To ensure that students are present for test day, it is highly recommended that they get a good night's rest, eat a plentiful breakfast in the morning, and arrive early (or on time) to the testing location on campus. We will be providing snacks and water/juice during the breaks, but students are welcome to bring a small snack to eat during the 5 or 10 min breaks.

 2 pencils, SAT
 approved calculator,
 and extra batteries.
