



**2019-2020 Free Application for Federal Student Aid (FAFSA)
Information and Documents Needed
-Dependent Student-**

The FAFSA needs to be completed each year you will be attending a postsecondary institution. The first step in filling out the FAFSA is to apply for an FSA ID. Both you and your parent/s will have to apply for your own FSA IDs. FSA IDs allow students and parents to sign the FAFSA electronically. Applying for an FSA ID can be done before we start your FAFSA application and takes about 5-10 minutes. The 2019-2020 FAFSA is valid for the period, July 1, 2019 to June 30, 2020.

The following is a checklist of information and documents needed for you to complete the 2019-2020 FAFSA during the SFIS FAFSA Workshop:

- _____ Your social security number
- _____ Your Parent/s SS#s, both parents if available.
- _____ Your date of birth (month, day, year)
- _____ Parent/s date of birth (month, day, year), both parents if available.
- _____ Valid email addresses for student and parent/s
- _____ Student and parent/s email usernames and passwords
- Each person must have their own email address. Email addresses cannot be shared.
- _____ Ask if your parents or anyone in your immediate family (mom, dad, your siblings) received any of these benefits in 2017 such as (check all that apply):
 ___Supplemental Security Income (SSI); ___Supplemental Nutrition Assistance Program (SNAP); ___Temporary Assistance for Needy Families (TANF);
 ___WIC
- _____ Ask if your parent/s paid child support in 2017. Amount? _____
- _____ Ask if your parent/s received worker’s compensation and/or disability benefits in 2017. Amount? _____
- _____ Estimated amounts of parents and student checking and/or savings accounts. These amounts can be your best estimates as of the day of the workshop.

Provide an average amount you feel comfortable sharing. If your parents do not have a checking or savings account that's ok.

_____ Ask your parents if they are considered a "Dislocated Worker." You are considered a Dislocated Worker if as of today you: Have been laid off, receive unemployment benefits as a result of being laid off, are a displaced homemaker, have been self-employed but no longer working due to factors beyond your control, are a spouse of an active duty member of the military and has lost a job or has been unsuccessful in finding a job as a result of being relocated.

Documents needed:

_____ Your parent/s 2017 income tax returns

_____ Your 2017 income tax returns if you worked and filed your own tax return.

*******Be sure to bring the actual tax return and not a summary or receipt.*******

_____ Your and your Parent/s W-2 forms for 2017

The FAFSA utilizes an electronic data transfer tool called the IRS Tax Retrieval Tool. After entering a tax payer's mailing address into the IRS website designated for FAFSA your and/or your parent/s tax information will automatically populate the FAFSA. This tool saves time and ensures accuracy. If the address is not accepted by the system we have the option to input the tax information manually.
