**BUS RULES**

**All rules that apply on the school campus apply at the bus stop and on the bus. Bus rules apply to day and evening routes. Students who violate rules are subject to the consequences outlined in the Student Rights and Responsibilities Handbook.**

- Student will follow the bus drivers' instructions and seating assignments.
- Yelling or using obscene language will not be permitted or tolerated.
- Controlled substances, alcohol, and smoking in any form is not permitted.
- Students must remain seated properly at all times while the bus is in motion.
- Students must NOT place their head, hands or arms outside the windows. Student will be responsible for keeping their seating area clean.
- No spitting or throwing of any object inside the bus or out of the bus windows.
- Physical display of affection is not allowed on the bus.
- Student will arrive on time to meet the bus. **The bus will not wait for any student beyond the designated departure times.** Students will have to be picked up after school if they miss the bus.
- **Boarding and exiting is only permitted at the designated bus stop. Buses will not pull over for late students. Parents will refrain from stopping, waving, flashing lights to pull bus over for a tardy student.**
- Student will ride the bus consistently; absences will automatically forfeit seat.

**Evening Bus Agreement**

**Late Bus Departs from MST at 6:15 pm.**

**Late bus service is strictly for students who are participating in a school sponsored activity, study hall, or athletic practice. Late bus privileges will be suspended and possibly revoked if the student abuses the late bus services. Abuse is defined as going off campus, roaming campus, attending sporting events, or going to restricted areas such as the EAC, basketball courts/playground area, or dormitories.** Please identify the after-school program your child will be participating in:
